Kotyark Industries & Yamuna Bio Energy has secured allocation for supply of 20,731 KL to OMCs out of which LOI worth ₹72.56 Cr has been received from IOCL

Kotyark Industries Limited, India's only pure play listed Biodiesel Company; and Yamuna Bio Energy Private Limited ("Transferor Company" in its proposed Scheme of Amalgamation) (together referred as "the Companies"), have announced receipt of Letter of Intent's against the tenders for procurement of Biodiesel filed by both the Companies. Thus far the Companies have received allocation sheets with a total procurement quantity of 20,731 KL, out of which it has already received two Letter of Intent's to supply a quantity of 7,843 KL worth ₹ 72.56 crores. The Companies had filed for a joint tender of 3 Oil Marketing Companies "OMCs". LOI for remaining quantity is expected to be received in coming weeks.
